





AN INTERNATIONAL COURSE ON LEGAL PLURALISM 8-11 January 2025

8-11 January 2025 Jakarta, Indonesia

Overview

From 8-11 January 2025 the Commission on Legal Pluralism in collaboration with the Universitas Indonesia Law School will organize a course on Legal Pluralism in Jakarta, Indonesia about theories, knowledge and methodologies of legal pluralism. The purpose of the 4-day course is to familiarize the participants with the current international debates and insights on socio-legal studies and legal pluralism and to offer a comparative perspective that allows them to rethink their own research and practical work.

Participation is limited to 30 persons to allow for maximum discussion. The participants will include academics and practitioners, e.g., NGO activists or government officials, who deal with issues related to legal pluralism, informal justice systems and social justice in their academic or professional work. During this intensive training, the participants will be given an opportunity to discuss their work and to build long-lasting intellectual connections with both other participants, and the instructors consisting of leading scholars and practitioners in their fields, allowing participants to become part of a growing international network.

Topics to be covered in the course include:

- Theoretical and conceptual aspects of legal pluralism
- Legal pluralism and forensic social anthropology: Intercultural justice in the Global South
- Tribal / customary / indigenous law and traditional authorities
- Human-nature relations: legal pluralism, property and rights of nature
- Legal pluralism and 'Science and Technology Studies'
- Religious family laws and human rights
- Legal pluralism research methodology

The course will include a half-day excursion and a participants' research forum.

Selection, Tuition, and Funding

The course is open to students enrolled in a PhD programme, recent PhD graduates, more senior scholars who are relatively new to the field of legal pluralism, and practitioners working directly on one or more of the topics to be covered in the course. Participants must demonstrate a level of proficiency in English that allows them to read and actively discuss relevant academic literature. Selection will be based on students' motivation to join the course.

The course fee is **200 EURO**. Participants will be responsible for the cost of their airfare, accommodation (affordable rooms are available on campus), meals and local transportation. A limited number of tuition waivers will be awarded to participants who demonstrate extreme financial need. In allocation of tuition waivers, the priority will be given to students coming from low- and middle-income countries. Depending on pending grant applications, some of the participants may be provided with free accommodation, local transportation and hospitality during the course.

Application, Contact and More Information

Individuals interested in participating in the course are invited to apply by **May 20, 2024**. The application should include a cover letter, brief curriculum vitae and evidence of English proficiency. Applications should be emailed to Bertram Turner (bert_turner@mailbox.org). Decisions will be made by June **20, 2024**.

The course will precede the International Conference of the Commission on Legal Pluralism, which will take place in Jakarta, Indonesia, from January 13-15, 2024. <u>Course participants are in principle expected to also present a paper at the conference.</u> Please realize that participation in the conference requires payment of a conference fee.
