The Commission on Legal Pluralism furthers knowledge and understanding of legal pluralism, with a focus upon theoretical and practical problems resulting from the interaction of different types of law, such as state law, international and transnational law, religious law, and customary law. It provides a meeting ground for the concerns of social and legal sciences in the study of law in society and the resulting power relations, and in the resolution of social problems. Among its main activities are the organization of international symposia; the initiation and encouragement of Regional Working Groups in different parts of the world; the organization and delivery of courses and workshops on legal pluralism; and publication of the journal, Legal Pluralism and Critical Social Analysis three times a year.
