Opening Plenary Session: "Rule of Law, Democracy, and Rights to Ecological Justice in Contemporary Indonesia"

This session aims to shed light on legal, democratic and environmental justice issues facing Indonesia today. The change of government in the last two years was characterised by a process of democratic regression due to abuse of power and the use of laws and court decisions for the benefit of power and nepotism. The majority of political parties in parliament and numerous state institutions appear to be compliant with this power. This has had a significant impact on public trust in the adherence of elites to the rule of law, leading to concerns about the decline of democracy and the exacerbation of social and ecological justice issues.

The four speakers – scholars and activists – will provide a detailed account of instances where law and policy have been used to define power rather than uphold democracy and deliver justice to the people.

**Professor Todung Mulya Lubis**, an outstanding lawyer and human rights activist will deliver his thoughts about "The failure of the state to uphold democratic principles as a result of the abuse of authority through legislative acts, judicial decisions and state institutions"

**Usman Hamid**, Executive Director of Amnesty International Indonesia and prominent human rights activist will share his knowledge and experience on "The alienation from

history and legal awareness and its implications for the directionlessness of the state and the future of the nation"

**Suraya Afif, Phd**, a knowledgable and dedicated anthropologist, environmental and indigenous activist, will provide her knowledge and experience on agrarian conflicts, extractive policies, and their implications for environmental damage, biodiversity and the absence of ecological justice.

**Prof. M.R. Andri Gunawan Wibisana**, a prominent professor in environmental law from Faculty of Law, UI will analyse various legal and policy issues that have resulted in the emergence of law violations, corruption in the field of natural resource management and public losses.

**Prof Sulistyowati Irianto**, legal anthropologist from Faculty of Law, UI, and long-standing board member of the Commission on Legal Pluralism, will take on the role of moderator in this session.

This plenary session commemorates Keebet von Benda-Beckmann (1946-2022) as an influential scholar of legal pluralism, highly respected colleague and dear friend for many. In close cooperation with her late husband Franz, she has made key contributions to the development of the fields of law and anthropology of law, with a focus on the role of legal pluralism. Through her research and publications, teaching and supervision of students, she has made an important contribution to the study of legal pluralism in diverse and changing socio-political and legal constellations, especially in Indonesia. Keebet's involvement as a founding member of the Commission on Legal Pluralism, long-term member of its Executive Body, and president (1997-2003), and as Associate Editor, author and reviewer of this journal since the early 1980s, have left an indelible impact on the field. This plenary is devoted to commemorate her life's journey and academic life-time achievements. We share our deep emotional and intellectual attachment to her. The plenary is the occasion of the launch of the special issue 'Remembering Keebet von Benda-Beckmann' of the journal Legal Pluralism and Critical Social Analysis (vol 56, 3, 2024).
