

AFRICAN LEGAL PERIODICALS:

A Bibliography

Introduction

This is a bibliography of the legal periodicals published in, for and about the nations of Africa. A preliminary bibliography was previously published in 59 Law Library Journal 93 (1966). Since then, a number of new periodicals have made an appearance; and, in some cases, additional information has been compiled about the older journals. Thus, a second edition of the bibliography now seems warranted.

The increasingly significant role of African legal periodicals is reflected in several recent general bibliographies which are listed at the end of this article. These and other standard bibliographic sources were used in the preparation of this list. Their coverage, however, is incomplete. And this bibliography has been heavily supplemented by information collected during several visits to African law libraries. While the bibliography is intended to be comprehensive, it is recognized that literal completeness is difficult to obtain. It is therefore urged that anyone who has information concerning these or other African law journals contact the bibliographers.
